

From AI to KPI:

The law department tech trends of 2024

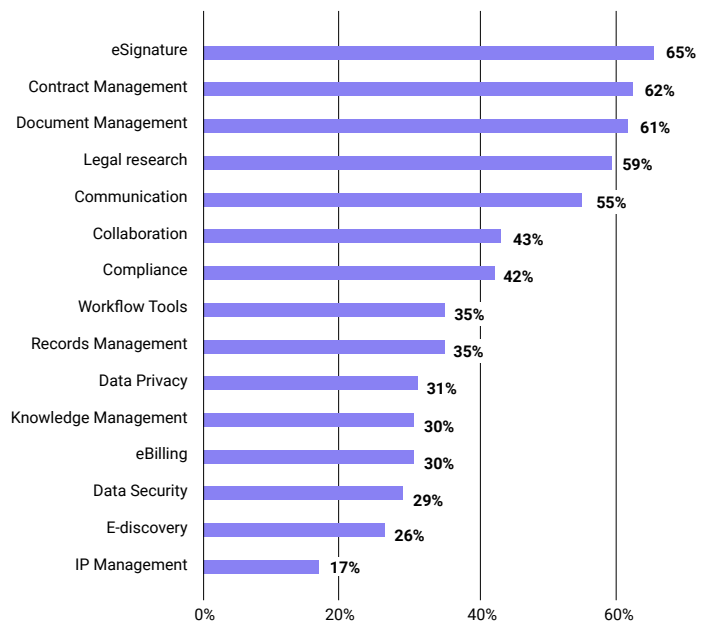
Above the Law (ATL) and iManage surveyed corporate legal professionals across a wide range of industries to gain a holistic view of workplace challenges and learn how implementing the right technology can help alleviate those struggles.

This survey was conducted between January 26 – March 5, 2024, with a total of 126 respondents.

Summary of Survey Results

Q1: What technology areas do you work with? (Select all that apply.)

Respondents work with a broad range of technology areas, most commonly eSignature, contract management, document management, legal research, and communication.

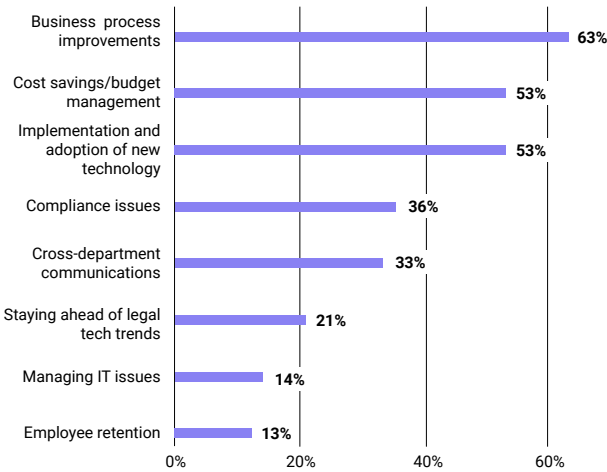

Q1: What are the top three challenges you face in your role?

The top three challenges respondents face:

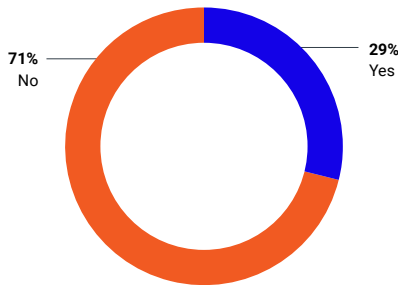
- Business process improvements
- Cost savings/budget management
- Implementation and adoption of new technology

Implementation and adoption of new technology is particularly important for those respondents in law departments with more than 50 employees.



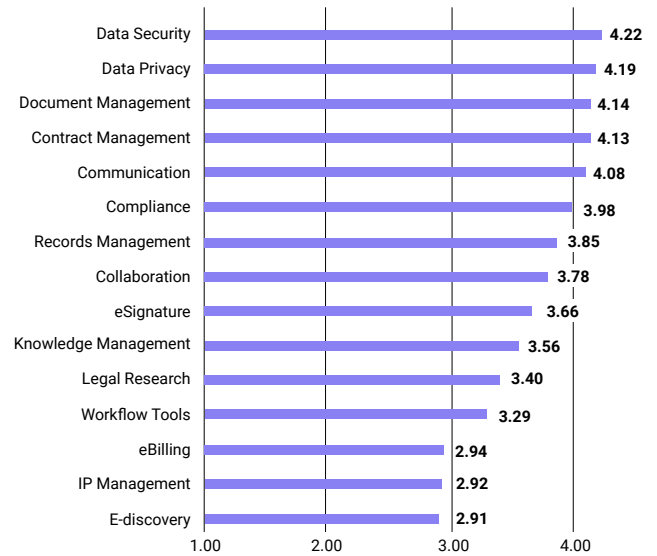
Q2: Do you feel you have the right technology in place to help with all of these challenges?

Less than one-third of respondents feel they have the right technology in place to help with these challenges.



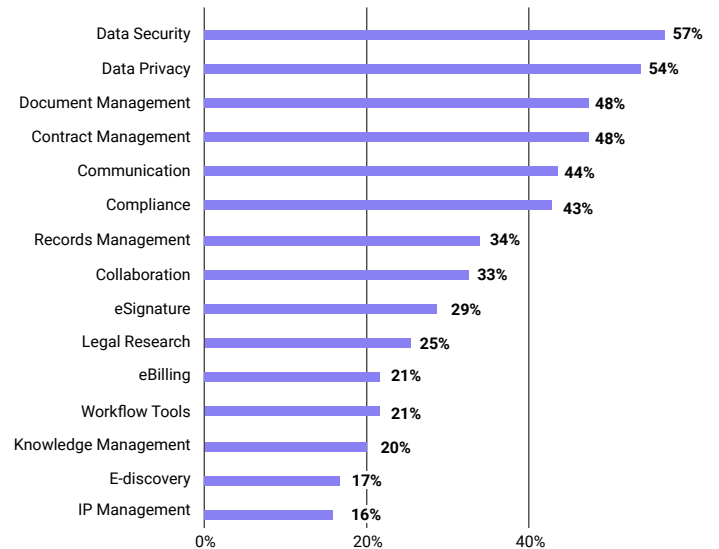
Q3: Please rate the importance of the following technology in the legal department's day-to-day work, with 5 being extremely important and 1 being not important at all.

The technologies rated highest in importance in terms of the legal department's day-to-day work include data security, data privacy, document management, and contract management.



More than half of all respondents rated both data security and data privacy "extremely important." Among those working in healthcare, 81% rated data privacy "extremely important."

Technology rated "extremely important" in the legal department's day-to-day work

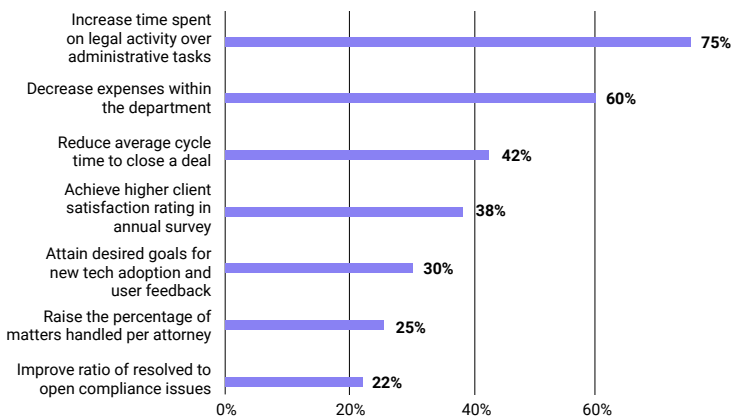


Q4: What do you consider your top three key performance indicators?

The top three KPIs among respondents:

- Increase time spent on legal activity over administrative tasks
- Decrease expenses within the department
- Reduce average cycle time to close a deal

Among those working in companies whose law departments employ 50 or more, increasing time spent on legal activity was cited as a top KPI by 97% of respondents.



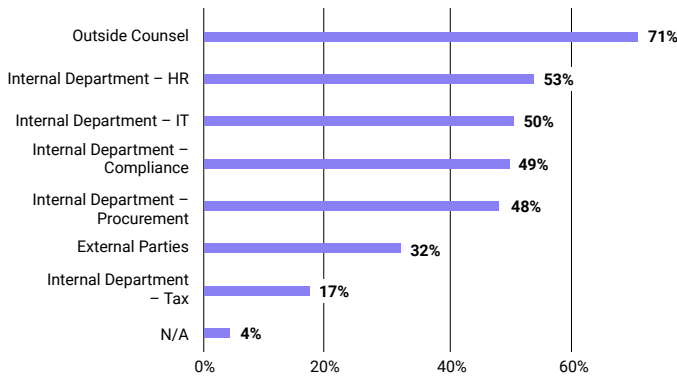
Q5: What are your biggest goals for 2024?

Top five responses

1. Develop strategies for adoption of AI
2. Improve efficiencies and productivity
3. Implement contract management system
4. Reduce legal spend
5. Improve cross-department communication

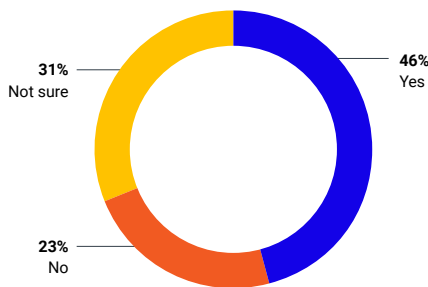
Q1: Which departments or stakeholders does the legal department collaborate with most often? (Select all that apply.)

More than two-thirds of respondents say that the stakeholder their department collaborates with most often is outside counsel. Internal departments with whom they work most frequently include HR, IT, Compliance, and Procurement.



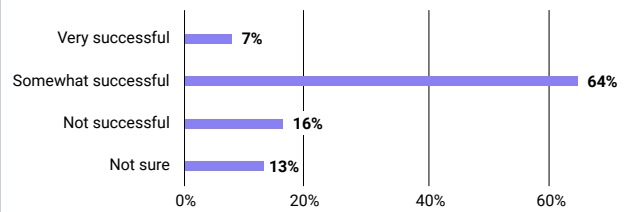
Q2: Do you have effective technology and tools to support that collaboration?

Less than half of respondents say they have effective technology and tools to support this collaboration. The number climbs to 75% among respondents in the largest legal departments.



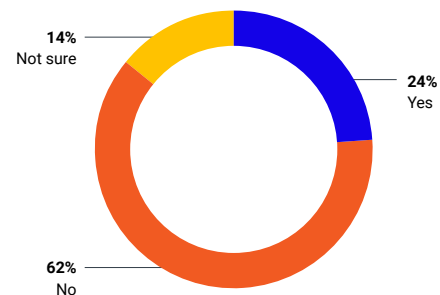
Q3: How successful do you feel you are in driving user engagement and adoption for legal technology?

The majority of respondents describe themselves as “somewhat successful” in driving user engagement and adoption for legal technology. Less than 10% feel “very successful,” while 16% say they are “not successful.”



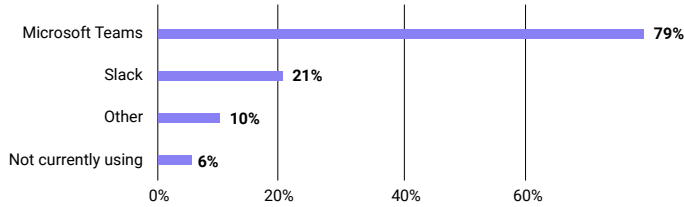
Q4: Do you have a formalized strategy for rolling out legal technology?

The majority of respondents describe themselves as “somewhat successful” in driving user engagement and adoption for legal technology. Less than 10% feel “very successful,” while 16% say they are “not successful.”



Q5: Which real-time messaging technology does your company currently use? (Select all that apply.)

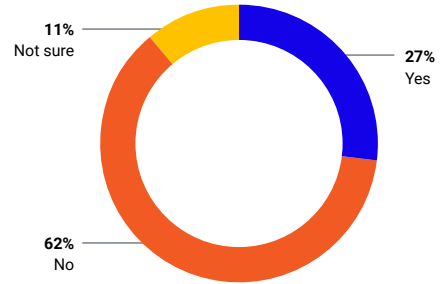
Nearly all respondents reported that their companies use some kind of real-time messaging technology, with Microsoft Teams by far the most common.



“Other” responses include Avaya, Google Chat, Skype, SMS, and Zoom.

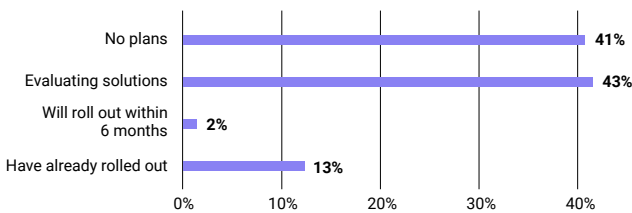
Q6: Do you have formalized rules for governing these messages?

While more than 90% of respondents’ organizations use messaging technology, less than 30% have formalized rules governing these messages. Even among those working at tech companies, less than half of respondents report having such rules.



Q1: Does your organization have plans to roll out generative AI tools or solutions to your legal team?

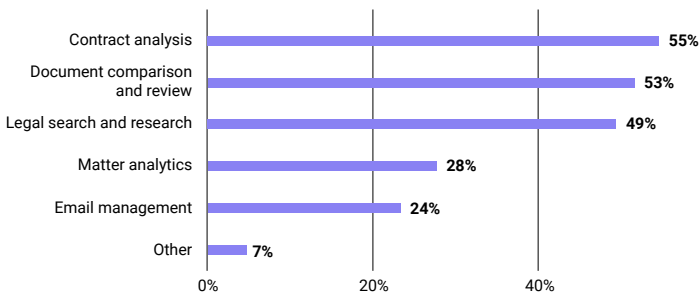
Few respondents have already rolled out or have immediate plans to roll out generative AI tools to their legal team. While many are currently evaluating solutions, more than 40% have no plans to introduce AI tools. Unsurprisingly, those who work in the tech sector have advanced furthest in this area: 41% of respondents have already rolled out AI solutions to their legal teams.



Q2: What does your organization see as the most appealing use cases for generative AI? (Select all that apply.)

The three most appealing use cases for generative AI, according to respondents, are:

- Contract analysis
- Document comparison and review
- Legal research

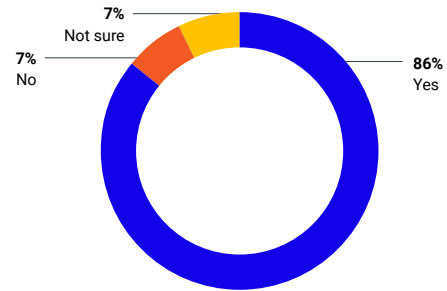

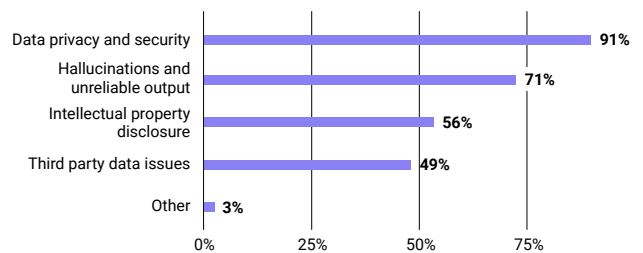
Q3: Is your organization concerned about potential security risks associated with generative AI?

Nearly everyone says their organization is concerned about the potential security risks associated with generative AI.



Q4: What specific risks are you most concerned about with regard to generative AI? (Select all that apply.)

The specific risks most frequently cited are data privacy and security, identified by more than 90% of respondents. A majority also worry about hallucinations and other unreliable output.

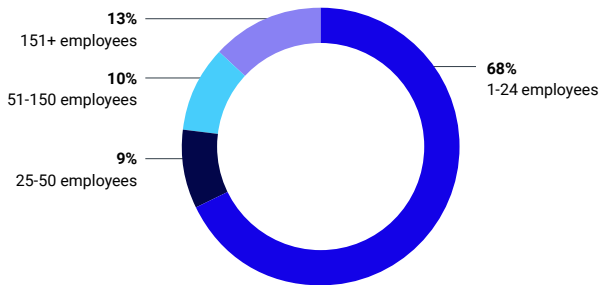

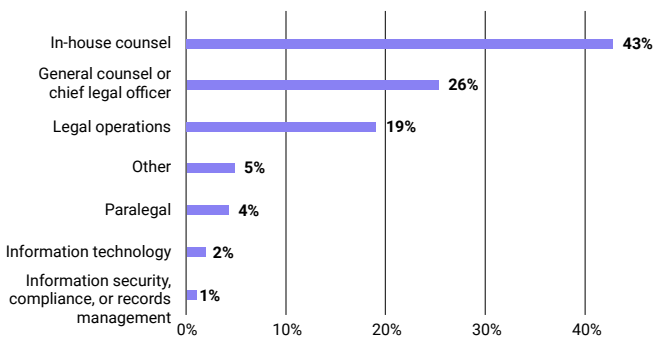
Q1: What is the size of your legal department?

The majority of respondents are in-house counsel, including GCs and CLOs. Most of the others are legal operations professionals.

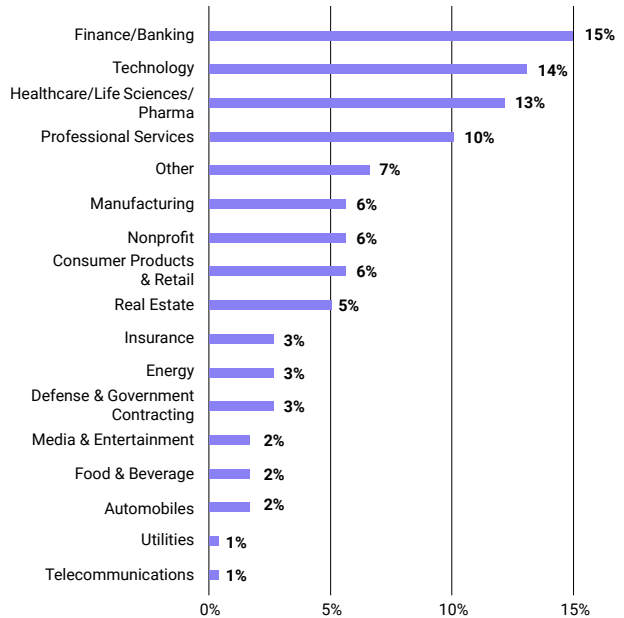
