The business challenge

Finding and collaborating documents

LHB&R Advogados handles large, complex cases that require the firm's unique expertise. Providing bespoke, high-quality services requires that the legal team is able to find the right documents, collaborate in-house with other practices and with clients and apply their knowledge without the distraction of underperforming technology or tools.

The firm's hybrid workplace creates added pressure to make documents accessible from anywhere. And while they had a file directory and dictates around file saving and naming conventions, these were not reliably followed, making it harder for staff to locate and share the correct files.

"Documents were filed by client or case, but unless they were named correctly, it was difficult to find them," explains Guilherme Rauen Silva Jardim, a partner at the firm. "It also increased the risk of data loss and duplicated effort. If we couldn't find a document, we had to re-create it, which is

time-consuming and inefficient."

When the team collaborated with other firms, they shared documents using OneDrive and email links. Working on the same document on the same document in real-time or even passing the document back and forth created version control issues.



Protecting client data

LHB&R Advogados must also assure clients

that their data is secure and accessed only by authorized personnel, in compliance with national data protection laws. To achieve this, they protected on-premises servers with firewalls, antivirus software, regular backups, and password protection for sensitive data.

"We wanted to move to the cloud both to increase security and to take back ownership of our document management," says Dr. Caio Julius Bolina, who is also a partner at LHB&R Advogados. "IT could restrict access to files using passwords, on request, but we worried about the potential of sensitive data being compromised if an unauthorized person obtained the password."

The solution

A staged migration to Brazil's leading knowledge work platform

Following an extensive evaluation, LHB&R Advogados implemented a suite of iManage solutions, including iManage Work 10 in the Cloud, iManage Share, and iManage Threat Manager. The partners were impressed by the platform's high levels of security and intuitive user experience.

The firm's implementation partner, Totvs, helped them choose the right solution. Despite having its own document management platform, Totvs recommended iManage as the best fit for their needs. "iManage is the most popular document management solution in Brazil and has great local language support documentation," notes Jardim.

A staged approach made the transition more manageable for LHB&R Advogados. Totvs provided training and set up the platform and system configuration in Portuguese. LHB&R Advogados re-evaluated their approach to document management and introduced new naming conventions to ensure staff could find the right documents in the new system.

The firm's data was deduplicated and migrated into iManage over a three-month period. They brought the most-used and most important Word documents over first and migrated PDFs, emails, and third-party files at a later stage. This helped staff acclimatize to the platform without feeling overwhelmed.

LHB&R Advogados created training manuals tailored for different roles and made learning resources available on demand.

Strong, comprehensive platform in the cloud

Legal work at LHB&R Advogados centers around iManage Work 10 in the Cloud. Staff can access the right documents from anywhere and enjoy an enhanced search experience. Other popular features include timestamps, which create a timeline to track a case's progress, and co-authoring capability. This enables colleagues to collaborate on documents in real time without experiencing version control issues.

"No matter where a file is saved with iManage we can always retrieve it using search," Jardim reports. "We can search by reference, client, case, or keyword, and iManage even finds files that weren't saved with the proper naming convention."

The team also uses iManage Share when sharing documents related to complex cases with clients or knowledge workers from other practices. Because Share is part of the iManage platform, this is more secure and efficient than using OneDrive.

Meanwhile, iManage Threat Manager monitors who is accessing documents, providing unprecedented levels of transparency into user behavior. Any unusual or unauthorized activity, such as a high volume of files being downloaded, is flagged, alerting the firm to potential risks.

Empowered workers and a secure environment

By adopting iManage Threat Manager with its iManage Work 10 in the Cloud implementation, LHB&R Advogados boosted security while reducing IT costs.

"We worked hard to keep our on-premises environment secure, but there was still a risk," says Dr Bolina. "Now iManage Cloud is our secure environment. We can track and block unauthorized access and move sensitive data to secure folders to protect it. The platform is scalable without forcing us to invest in more on-premises technology or backups."
