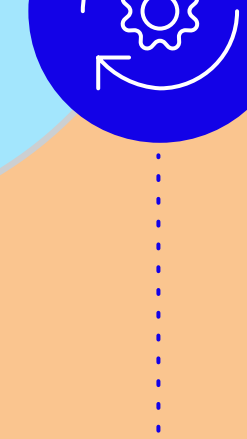
Microservices allow iManage and partners to quickly deploy production-ready applications aligned with customer needs.
