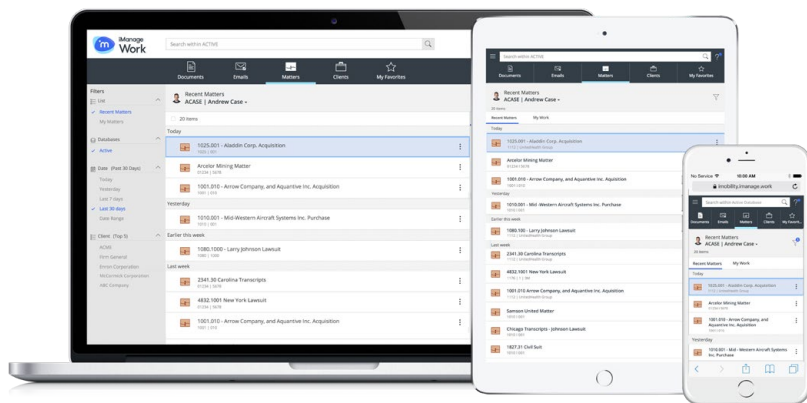

365, Outlook, Gmail, and more.

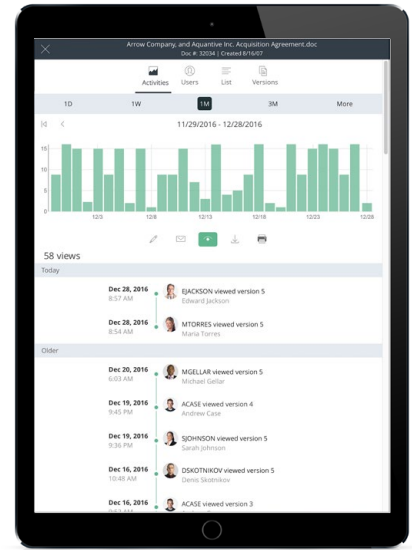
Documents are saved directly into iManage Work with the Save icon in Office, and the system automatically suggests filing locations for emails and saves them with a single click.
